Unless later ordered by the Chairman, the hearing will adjourn at approximately 5:00 p.m. each day.

The hearing may conclude earlier or later than anticipated, depending upon the number of parties that intervene, the amount of testimony presented, the amount of public comment, and the time needed for deliberations by the Committee
